“WHEREAS, Section 16 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare, within their respective territorial jurisdictions;

“WHEREAS, Section 2.3 of the Administrative Order No. 07 series of 2021 of the Department of Agriculture defines Barangay Biosecurity Officers as Community/Village-based Animal Technicians (CBAT), Barangay Animal Health Workers (BAHW), para-veterinary workers, Barangay Livestock Aide (BALA), volunteer veterinarians who are not resident or consulting veterinarian of any farm, or any person assigned by the city/municipality at the Barangay shall be known as Barangay Biosecurity Officers (BBO) who will appointed, designated and registered as the frontliners of the Bantay ASF (African Swine Fever) sa Barangay Program and shall have specific responsibilities indicated in this order;


