GRANTING THE FORMER THE RIGHT TO MANAGE AND DEVELOP THE PROPERTIES OWNED BY MADECO SITUATED IN BARANGAY SAN JUAN, BULALACAO, THIS PROVINCE




SEC. 2. This special ordinance shall take effect immediately.
