SPECIAL ORDINANCE NO. 07-11-23

SPECIAL ORDINANCE AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE HONORABLE ARTHUR C. YAP, SECRETARY, DEPARTMENT OF AGRICULTURE FOR GRANTING THE AMOUNT OF FIVE MILLION PESOS (Php 5 M) OF THE LATTER TO THE FORMER TO BE USED FOR THE REHABILITATION OF MAUJAO IRRIGATION PROJECT SITUATED AT BARANGAY MAUJAO, MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO
