ORDINANCE AMENDING SECTION 2.4 OF ORDINANCE NO. 04-08-039-B ENTITLED " AN ORDINANCE CREATING A PHILHEALTH CAPITATION FUND FROM THE PROCEEDS OF THE OUTPATIENT CONSULTATION AND DIAGNOSTIC BENEFIT PACKAGE TO BE PROVIDED BY THE PHILHEALTH INSURANCE CORPORATION (PHILHEALTH) FOR QUALIFIED INDIGENT FAMILIES OF THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO UNDER THE INDIGENT SECTOR COMPONENT OF THE NATIONAL HEALTH INSURANCE PROGRAM (NHIP)

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro that:

SECTION 1. Section 2.4 of Ordinance No. 04-08-039-B is hereby amended to read as follows:


"Section 2.4. Eighty percent (80%) of PCF shall be allotted for the purchase of medicines, procurement of medical equipments and repair and rehabilitation of the Municipal Health Office, ten percent (10%) allocated for the Municipal Health Officer and ten percent (10%) allocated for the staff of the Municipal Health Office."


SECTION 4. This ordinance shall take effect immediately.






