ORDINANCE NO. 08-12-93

AMENDING SECTION 3E.02, ARTICLE E OF THE 2004 NEW REVENUE CODE OF THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO, "PROVISION ON LARGE CATTLE REGISTRATION AND TRANSFER FEES"

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

SECTION 1. Section 3E.02, Article E of the 2004 New Revenue Code of the Municipality of Bulalacao, Province of Oriental Mindoro is hereby amended to read as follows:

" Section 3E.02. Imposition of Fees. There shall be collected by the Municipal Treasurer the following fees:
