SPECIAL ORDINANCE NO. 10-08-79

SPECIAL ORDINANCE AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE KAPISANAN NG MGA KABATAANG NAGLILINGKOD (KAPISANKANA) REPRESENTED BY ITS PRESIDENT, MISS KAREEN R. GONZALES FOR THE GRANT OF PHP350,000.00 BY THE MUNICIPAL GOVERNMENT TO THE LATTER TO BE USED FOR FINANCIAL SUPPORT TO THE GRADUATES OF THE BULALACAO TECHNICAL AND VOCATIONAL COLLEGE WHO ARE APPLYING FOR JOBS ABROAD AND RATIFYING THE SAME CONTRACT



SEC. 3. This Special Ordinance shall take effect immediately.




