**SPECIAL ORDINANCE NO. 10-06-74**

SPECIAL ORDINANCE AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE LAND BANK OF THE PHILIPPINES, PINAMALAYAN BRANCH, PINAMALAYAN, ORIENTAL MINDORO FOR GRANTING THE MUNICIPAL OFFICIALS AND EMPLOYEES OF THE MUNICIPAL GOVERNMENT OF BULALACAO, ORIENTAL MINDORO WITH SALARY LOANS EQUIVALENT TO EIGHT (8) MONTHS OF THEIR BASIC SALARY AND RATIFYING THE SAME AGREEMENT

**BE IT ORDAINED** by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

**SECTION 1.** The Municipal Mayor, the Honorable Ernilo C. Villas is hereby authorized to enter into a Memorandum of Agreement with the Land Bank of the Philippines, Pinamalayan Branch, Pinamalayan, Oriental Mindoro for granting the municipal officials and employees of the Municipal Government of Bulalacao, Oriental Mindoro with salary loans equivalent to eight (8) months of their basic salary and that the same agreement is hereby ratified;

SEC. 2. This Special Ordinance shall take effect immediately.


ENACTED this 21<sup>st</sup> day of June, 2010, Bulalacao, Oriental Mindoro.


