## SPECIAL ORDINANCE NO. 13-04-32

### SPECIAL ORDINANCE AMENDING ORDINANCE NO. 12-02-07-A, SERIES OF 2012

**Sponsor:** Honorable Gideon B. Abuel  
**Chairman:** Committee on Education, Culture and Sports

**BE IT ORDAINED** by the Sangguniang Bayan of Bulalacao,  
Oriental Mindoro:

**SECTION 1.** Special Ordinance No. 12-02-07-A, series of 2012  
entitled "Approving and adopting the 2012 revised guidelines of the  
Municipal Scholarship Program of the Local Government Unit of  
Bulalacao, Oriental Mindoro" is hereby amended to read as follows:

"The 2012 revised guidelines of the Municipal Scholarship Program of  
the Local Government Unit of Bulalacao, Oriental Mindoro is hereby  
amended to be read as follows:

**B. Eligibility Requirements**

- a. To allocate two (2) scholars from BNHS Maasin-Annex  
as Slot C
- b. To allocate two (2) scholars from BNHS-Benli Annex as Slot E

**D. Courses Offered**

- a. To include Bachelor of Science in Elementary Education and Secondary Education among the courses offered.

**E. Selection Process**

- a. Item No. 4 be changed by interchanging card general average from 35% to 15% and interview from 15% to 35%.

**F. Situations which maybe grounds for Termination**

- a. Item No. 2 must be classified that two (2) subjects with grade below 78% in two (2) consecutive semesters.

**SEC. 2.** Ordinances inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly;

**SEC. 3.** This Ordinance shall take effect immediately
