- ii. Construction of 1 unit 1 Classroom School Building (Barangay Balatasan);
- iii. Improvement of Isolation Facility and Purchase of Amenities (Brgy. Cabugao);

- iv. Construction of Child Development Center (Barangay Cambunang).
- v. Construction of Multi-Purpose Building (Barangay Campaasan)
- vi. Improvement of Multi-Purpose Building and Purchase of Amenities (Brgy. Maasin)
- vii. Repair and Concreting of 0.115 km Access Road (Barangay Maujao);
- viii. Construction of Multi-Purpose Building (Barangay Poblacion);
- ix. Improvement of Multi-Purpose cum Evacuation Center and Purchase of Amenities (Barangay San Francisco);
- x. Construction of 1 unit 1 Classroom School Building (Barangay San Juan);
- xi. Construction of Multi-Purpose Building (Barangay San Roque);


RESOLVED FURTHER, That: Any change or alteration in the Mutual Partnership Agreement originally presented shall have no effect and therefore null and void;


RESOLVED FINALLY, That: Any legal encumbrance that may arise in the execution and actual application of this Mutual Partnership Agreement shall be the sole responsibility of the heads of Implementing Offices or Units;
