BERNABE TO GIVE PRIORITY TO THE BULALACAO TRANSPORT COOPERATIVE (BTC), BULALACAO, ORIENTAL MINDORO IN THE GRANT OF FRANCHISE IN THE ROUTE PLYING FROM BULALACAO TO ROXAS AND VICE VERSA**

**"WHEREAS**, the LTFRB is responsible for promulgating, administering, enforcing and monitoring compliance of policies, laws and regulations of public land transportation system;

**"WHEREAS**, the agency is in charge of granting franchise or accreditations and regulating public vehicles such as utility buses, mini buses, public utility jeepneys, utility vehicles, express buses, filcab service, school services, taxis, Transportation Network Vehicles Services (TNVS) and tourist transport services;

**"WHEREAS**, the Bulalacao Transport Cooperative (BTC) in Bulalacao, Oriental Mindoro is composed of operators and drivers plying the route from Bulalacao to Roxas and vice versa had grouped together to meet their common economic, social and cultural needs and aspirations through a jointly-owned and democratically controlled business which are often more focused on services for members than for investments;

“WHEREAS, the Bulalacao Transport Cooperative is primarily composed of members who are bonafide residents of Bulalacao, Oriental Mindoro. The BTC expressed its intention to get and be granted a franchise from LTFRB to render transport services within the route from Bulalacao to Roxas and vice versa to which this Sanggunian finds it favorable to the riding public particularly the people of Bulalacao; **Now, therefore, be it**

**RESOLVED AS IT IS HEREBY RESOLVED To:** Earnestly request the Land Transportation Franchising and Regulatory Board (LTFRB), Regional Office thru its Regional Director, *Loumer P. Bernabe* to give priority to the Bulalacao Transport Cooperative (BTC), Bulalacao, Oriental Mindoro in the grant of franchise in the route plying from Bulalacao to Roxas and vice versa;
