RESOLUTION NO. 5

(ORDINANCE NO. 1)

AN ORDINANCE AMENDING SECTION 1 OF AN ORDINANCE NO. 5, RESOLUTION
NO. 26, SERIES OF 1964;

Be it ordained by the Municipal Council of Bulalacao:

That:-

Section 1.- Ordinance Amending section 1 of an Ordinance No. 5,
resolution No.26, series of 1964 to be read as follows as:

(a) each proprietor or operator of any sail-boat; motor-boat;
and motor-boat with sail or any other motor boats which carries pas-
sengers, loading and unloading cargoes from one barrio to barrio,
from one municipality to other municipalities and/or adjacent mun-
icipality entering and berthing in the municipal waters, as in rivers,
harbor of Bulalacao, Oriental Mindoro, the following anchorage rates
of fees be charged or collected to wit:

- (a) Motor-boat with one fourth (1/4) ton to one (1) ton
capacity per anchorage fee to be collected, - - - - - P .25
- (b) Motor-boat from one (1) ton to five (5) ton
capacity per anchorage fee be collected, - - - - - P .50
- (c) Motor-boat and/or motor boat-with sail,
sail-boat from five (5) tons up in capacity
per anchorage fee be collected, - - - - - P 1.00

Section 2.- The purpose of this Ordinance is to raise the revenue
income of this municipality by imposing license taxes fees on all
persons engaged in any business.

Section 3.- PENALTY: Any proprietor, operator, owner of any motor boat, sail-boat as herein mentioned in the above-section 1 (a) (b) (c) of this Ordinance having been caught violating the provisions as stipulated in this Ordinance shall upon conviction for its offense be punished by a fine of not less than ten pesos (P10.00) nor more than twenty-five pesos (25.00) and imprisonment of not less than ten days nor more than twenty-five days or both such fine and imprisonment in the discretion of the court.

Section 4.- Any Ordinance or Ordinances or part thereof, in conflict or inconsistent with the provisions of this Ordinance, shall be null and void.






Section 5.- EFFECTIVITY: This Ordinance shall take effect after ten days of its passage.


