The meeting was called to order at 9:30 O'clock in the morning.

The calling of the roll was performed by the Recorder with the members answering present when their respective names were called.

The minutes of the previous meeting was also read by the Recorder and there was no objection so on motion of Hen. Ulpiano C. Pandino, seconded by Hen. Perpetua C. Gantes, the minutes stand as confirmed.

Resolution N. 62 was disregarded due to personal arrangement of Mayor Delores S. Bago together with Councilman Wilfredo F. Embile with the Provincial Commander (PC) on December 5, 1981.. UNANIMOUSLY APPROVED.

Resolution N. 54, dated October 26 is amended by Resolution No. 64 on motion of Hen. Ulpiano C. Pandino, seconded by Hen. Amparo S. Gregorio. While Resolution requesting the Ministry of Local Government, Manila to increase the 20% Development allotment to the Municipality of Bulalacao to 40% which was moved by Hen. Ulpiano C.
