RESOLUTION NO. 65 ✓

RESOLUTION INFORMING THE COMMISSIONER, COMMISSION ON ELECTIONS, MANILA THAT THE ELECTION REGISTRAR IN THIS MUNICIPALITY, SELDOM HOLD OFFICE.

WHEREAS, the municipality of Bulalacao, Oriental Mindoro has an Election Registrar who kept not only the records of voters, but to take charge during Local and National elections, as well;

WHEREAS, it has been observed that during National and Local elections in this Municipality, the names of voters wherein they registered could not be found in the Registry Book so that many voters cannot cast their votes;

WHEREAS, it has been also observed that the Election Registrar of this town hold office only once a month or sometimes none;

WHEREAS, because of the irregularity of holding office of the Election Registrar in this town, the records of voters are not properly arranged;

NOW, THEREFORE, resolved, as it is hereby resolved, to inform the Commissioner, Commission on Elections, Manila of the irregularity of the holding of Office of the Election Registrar of Bulalacao, Oriental Mindoro, despite she is being paid by the government;

RESOLVED, FURTHER, that copy of this Resolution be furnished the Commissioner Commission on Elections, Manila for his information and guidance....
