RESOLUTION NO. 47

The Sangguniang Bayan of Bulalacao, on motion of Hon. Juanita T. Amparo,

RESOLVED, to approve the following Ordinance:

ORDINANCE NO. 14 ✓

ORDINANCE NO

PROHIBITING PERSONS TO ENTER THE PREMISES OF THE CENTRAL SCHOOL AND ALL BARANGAY SCHOOLS, BULALACAO, ORIENTAL MINDORO FROM 6:00 PM TO 6:00 AM AND SHALL PROVIDE FINES AND PENALTIES FOR VIOLATION HEREOF

WHEREAS, it has been observed that people are entering the premises of the Central School and all barangay schools this Municipality during night time and destroy school properties;

WHEREAS, in order to stop this malicious act, the Sangguniang Bayan hereby Ordains, that:

SECTION 1. It is unlawful to any person or persons to enter in the premises of the Central School and barangay schools, this Municipality from 6:00 PM to 6:00 AM to avoid lost or damage of school properties;

SECTION 2.-Persons or persons found by the authorities inside the premises of Central School and all barangay schools within the time prescribed in Section hereof, shall be apprehended and brought to the LNP Barancks for proper investigation and shall be made liable for any damage or damages cause to school properties hereof;

SECTION 3. Sign boards of prohibition whereby indicating the Number of the Resolution and Ordinance shall be placed by the school authorities in conspicuous places visible to the public;


SECTION 4. Violation of this Ordinance or parts hereof, shall be fined the amount of ₱50.00 to ₱200.00 or imprisonment of 10 to 30 days or both such fine and imprisonment at the discretion of the court;


SECTION 5. Ordinance or Ordinances inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly;


SECTION 6. This Ordinance shall take effect immediately.


UNANIMOUSLY APPROVED.
