REQUESTING DEPUTY MINISTER, JOSE LEVISTE OF THE MINISTRY OF TRADE, OFFICE OF THE PRIME MINISTER, MANILA FOR ONE HOSPITAL AMBULANCE FOR THE EXCLUSIVE USE OF THE MUNICIPAL GOVERNMENT OF BULALACAO, ORIENTAL MINDORO

WHEREAS, the municipality of Bulalacao is located in the Southernmost of the Province of Oriental Mindoro;

WHEREAS, this municipality has no government Physician nor Private practitioner to safeguard the life of the people;

WHEREAS, patients who cannot afford to hire vehicle in going to Roxas General Hospital, Roxas Oriental Mindoro die without seeing a Doctor;

WHEREAS, considering the far distance of this town from Roxas General Hospital which is 46 kilometers and the Provincial Hospital of Calapan which is 186 kilometers, one Hospital Ambulance for the exclusive use of this municipality is indispensable;

NOW, THEREFORE, on motion by Hon. Jose P. Paigao, duly seconded by Hon. Edilberto M. Pajila, be it;

RESOLVED, as it is hereby resolved, to request Deputy Minister Jose Leviste of the Ministry of Trade, Office of the Prime Minister, Manila for One Hospital Ambulance for the exclusive use of the Municipal Government of Bulalacao, Oriental Mindoro;

RESOLVED, FURTHER, that copies of this resolution be furnished, Deputy Minister Jose Leviste, of the Ministry of Trade, Office of the Prime Minister, Manila for his information and favorable consideration....
