The session was called to order at 9:30 o'clock in the morning.

The calling of the roll was performed by the Secretary with the members answering present when their respective names were called.

The minutes of the previous session was also read and there no objection so on motion of Hon. Ignacio Silang, duly seconded by Hon. Sanny Madra, the minutes stands as confirmed.

A draft resolution requesting Minister Ramon Mitra Jr. to retain Mr. Rodolfo Comia as Provincial Agriculturist was presented and deliberated by Hon. Emelio Gregorio. In his agguementation he said, Mr. Rodolfo Comia is a Mindoreno and he has that love and symphaty for the progress of this Province. He added that to assign other person in his behalf will result to tremendous changes in the organization of Polices and programs in the government.

At this juncture Hon. Emelio Gregorio move and duly seconded by Hon. Angelico Lignes for the approval of the Resolution. In the other hand Hon. Leodigario Gonzales, objected to the Resolution stating among other things that Mr. Rodolfo Comia is not known to the people and has not even come to this Municipality. He further argued that he must show first his accomplishment before we could support him.

Hon. Emelio Gregorio further argued that it is not necessary for Mr. Rodolfo Comia to come to every municipality and whatever programs to be implemented must be delegated to his field personnels.

The Presiding officer upon knowing that there was a division of the house decided to come to votation to find out the Pro & Cons. Four SB members were infavor of the approval of the resolution, namely: Hon. Emelio Gregorio, Hon. Angelico Lignes, Vice Mayor Ludovico Sibang and Hon. Ignacio Silang. Those who are not infavor were: Hon. Leodigario Gonzales, Hon. Sanny Madra and Hon. Wilfredo Alejandro.

In view of majority vote cast infavor of the resolution, the presiding officer declared that the resolution was.. UNANIMOUSLY APPROVED.
