RESOLUTION NO. 15 ✓

REQUESTING HER EXCELLENCY PRESIDENT CORAZON C. AQUINO, MALACANANG, MANILA FOR THE ASSIGNMENT OF PERMANENT JUDGE IN THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO

WHEREAS, Bulalacao is an isolated town and located in the Southernmost of the Province of Oriental Mindoro;

WHEREAS, with the circuitisation of Municipal Courts, no judge is now holding court sessions in the municipality of Bulalacao, Oriental Mindoro;

WHEREAS, the municipality of Mansalay where court trials were held is 46 kilometers away from the municipality of Bulalacao and considering this far distance plus the enormous expenses incurred during the trial, poor and indigent people cannot afford to pursue their case in court;

WHEREAS, criminality is rampant in this municipality but same were not filed in court;

WHEREAS, the people of Bulalacao thru: The Sangguniang Bayan of Bulalacao most respectfully prays to Her Excellency President Corazon C. Aquino to assign permanent judge in the municipality of Bulalacao, Oriental Mindoro;

NOW, THEREFORE, resolved as it is hereby resolved to send a copy of this resolution to Her Excellency President Corazon C. Aquino, Malacanang Manila for consideration...
