" RESOLUTION NO. 93-11-71

REQUESTING THE PROVINCIAL AUDITOR, COMMISSION ON AUDIT, CALAPAN, ORIENTAL MINDORO TO SUBMIT TO THIS SANGGUNIANG BAYAN COPIES OF THE REPORT OF THE AUDIT IT MADE ON THE ACCOUNTS AND FINANCIAL RECORDS OF THE FIFTEEN (15) COMPONENT BARANGAYS OF THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO

"WHEREAS, it is provided in Section 334 par (c) of RA7160 and in par (e) Article 425 of its Implementing Rules and Regulations that the financial records of the barangay such as books of accounts, ledgers, statements of income and expenditures, balance sheets, trial balances, and other documents shall be kept in the office of the municipal accountant in a simplified manner as may be prescribed by COA which representatives shall audit said accounts and financial records of the barangay annually, or as often as may be necessary, and shall submit an audit report thereon to the sangguniang bayan;

"WHEREAS, this body, being the reviewing authority of the barangay budgets, is aware of the wisdom of the above provision, wishes to know what the COA has found out during their review of financial accounts and records of the barangays of this Municipality;

NOW THEREFORE: RESOLVED AS IT IS HEREBY RESOLVED to request the Provincial Auditor, Commission on Audit, Calapan, Oriental Mindoro to submit to this sanggunian copies of the report of the audit it made on the accounts and financial records of the fifteen (15) component barangays of the municipality of Bulalacao, Oriental Mindoro in accordance with Section 334 par (c) of RA7160 otherwise known as the Local Government Code of 1991;



Oriental Mindoro for their information.


