" RESOLUTION NO. 93-08-057

APPROVING THE ESTABLISHMENT OF DETACHMENT STATION MARITIME COMMANDS, PHILIPPINE  
NATIONAL POLICE, IN THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO

"WHEREAS, there has been rampant illegal fishing occurring within the territorial waters of the country, particularly at this Municipality, perpetrated by unscrupulous persons to the detriment of our national aquatic resource and compromising the interests of the future generations of Filipinos;

"WHEREAS, there is an immediate need for stopping this nefarious activity as it deprives the future generations with vital source of food and jeopardizes further the sorry state of our national aquatic resource;

"WHEREAS, prevention and suppression of all forms of illegal fishing methods as well as the operation against illegal entry, smuggling, customs frauds and other violations of maritime laws are among those powers and responsibilities granted to the personnels of Maritime Commands;

RESOLVED. AS IT IS HEREBY RESOLVED that the establishment of a Detachment Maritime Command in the Municipality of Bulalacao, Oriental Mindoro, under the supervision of the Fourth Maritime District, Headquarters Maritime Station 402nd, be approved;
