PETITIONING BOTH SANGGUNIANG PANLALAWIGANS OF OCCIDENTAL MINDORO AND ORIENTAL MINDORO TO DEFINE THE EXACT BOUNDARIES OF MAGSAYSAY, OCCIDENTAL MINDORO AND BULALACAO, ORIENTAL MINDORO

"WHEREAS, there is a great need to provide clarity in the definition of territorial jurisdiction between the municipalities of Magsaysay, Occidental Mindoro and Bulalacao, Oriental Mindoro, so as to avoid any possible boundary disputes in the future;

"WHEREAS, the immediate and prompt determination of the exact area of jurisdiction of these two municipalities will redound and contribute greatly to the stability of economic, political and social conditions of the residents of Magsaysay, Occidental Mindoro and Bulalacao, Oriental Mindoro;

NOW THEREFORE: RESOLVED AS IT HEREBY RESOLVED to petition both Sangguniang Panlalawigans of the provinces of Occidental and Oriental Mindoro to determine the exact boundaries of Magsaysay, Occidental Mindoro and Bulalacao, Oriental Mindoro, so as to avoid any possible boundary disputes in the future and to provide economic, political and social stability among the residents;

RESOLVED FURTHER, to furnish copies of this resolution the Sangguniang Panlalawigan of Occidental and Oriental Mindoro, Governor Rodolfo G. Valencia, Calapan, Oriental Mindoro and Hon. Jesus M. Punzalan, Congressman, District II, Oriental Mindoro, House of Representatives, Diliman, Quezon City, for their information and appropriate action.


