RESOLUTION REQUESTING THE SECRETARY OF THE DEPARTMENT OF AGRARIAN REFORM TO ALLO-  
CATE FUNDS FOR THE CONSTRUCTION OF FARM TO MARKET ROADS IN THE BARANGAYS COVERED  
BY THE AGRARIAN REFORM PROGRAM IN THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO

"WHEREAS, Section 35 of Republic Act No. 6657 otherwise known as the Compre-  
hensive Agrarian Reform Law of 1988 provides that infrastructure development and  
public works in areas and settlements providing suitable barangay sites, potable  
water and power resources, irrigation systems and other facilities for a sound  
agricultural development plan;

"WHEREAS, it is necessary to create a just and viable socio-economic struc-  
ture in agriculture conducive to greater productivity and higher incomes through  
support services such as the construction of farm to market roads;

"WHEREAS, transport and communication infrastructure contribute to agricul-  
tural and rural development as they provide benefits such as :

1. They facilitate the movement of products from farms to market ;
2. They reduce post-harvest losses;
3. They result in better and more stable prices received by farmers and lower prices paid by consumers;
4. They connect rural markets with one another and the rural sector with the rest of the economy , and thus, increase the trading of goods and services in the rural areas, and
5. They will attract more private investors.

"WHEREAS, agrarian reform is being implemented at this Municipality and  
several hundreds of hectares have already been awarded to their tenants;

"WHEREAS, it is imperative that land recipients be accorded with adequate  
and proper support services;


NOW THEREFORE ; for and in consideration of the foregoing premises the  
Sangguniang Bayan of Bulalacao, Oriental Mindoro, RESOLVED as it HEREBY RESOLVES  
to request the Secretary of the Department of Agrarian Reform to please allocate  
funds for the construction of barangay roads covered by agrarian reform program  
within this municipality;

RESOLVED FURTHER, to submit copies of this resolution to Hon. Ernesto D. Garilao, Diliman Quezon City, the Regional Director, DAR, Region-4, Pasig Metro Manila, PARO, Calapan, Oriental Mindoro and MARO, Bulalacao, Oriental Mindoro for their information and kindest approval.


