RESOLUTION REQUESTING HON. JESUS M. PUNZALAN, CONGRESSMAN, SECOND DISTRICT-ORIENTAL MINDORO FOR ADDITIONAL TWO HUNDRED THOUSAND PESOS (P200,000.00), FROM HIS COUNTRYWIDE DEVELOPMENT FUND, FOR THE COMPLETION OF SPORTS COMPLEX, OF BULALACAO


NOW THEREFORE, be it:
