REQUESTING THE REGIONAL DIRECTOR, DEPARTMENT OF HEALTH, QUEZON CITY TO EXTEND DENTAL SERVICES IN THE 15 BARANGAYS OF BULALACAO, ORIENTAL MINDORO

WHEREAS, no Government Dentist is assign in this town to render Dental services in the different barangay particularly to the School Children;

WHEREAS, there are many people as well as school children in the rural areas who were suffering from teeth diseases who need Dental care;

WHEREAS, it can be recalled that in previous years Dental services was extended to the people in the rural areas;

WHEREAS, assignment of government Dentist to the fifteen barangays in this town at least once a month is indispensable;

NOW, THEREFORE on motion of Councilor Emilio T. Gregorio, duly seconded by Councilor Leadigario Gonzales, be it;

RESOLVED, as it is hereby resolved, to request the Secretary, Department of Health, Quezon City, Metro Manila to assign Government Dentist to perform Dental services at least once a month in every barangay in this Municipality, free of charge;

RESOLVED, FURTHER, that a copy of this resolution be furnished, the Hon. Secretary, Dept. of Health, Quezon City, Metro Manila for consideration and proper action, and the Provincial Health Officer, Calapan, Oriental Mindoro for his information, guidance and reference. .
