RESOLUTION GRANTING AUTHORITY TO THE MUNICIPAL MAYOR TO REPRESENT THE MUNICIPAL GOVERNMENT IN ENTERING INTO A MEMORANDUM OF AGREEMENT WITH THE DILG REGARDING THE PROSECUTION OF THIS MUNICIPALITY'S "TAX CODIFICATION", MUNICIPAL PROFILE AND COMPREHENSIVE DEVELOPMENT PLAN" PROJECTS

WHEREAS, the Department of Interior and Local Government thru its Regional Office No. 4 has evolved a "Developmental Interposition on Local Governance thru Research-Oriented Approach (DILG-ROA) Program which aimed in enhancing the fiscal, administration and technical capabilities of local government units;

WHEREAS, this municipality has indentified two (2) projects that can be prosecuted under the said Program, such as:

1. Tax Codification
2. Municipal Profile and Comprehensive Development Plan

WHEREAS, the importance of undertaking the above mentioned project can not be ever-emphasized;

NOW, THEREFORE, on motion of Hon. Nenito S. Ambong duly seconded by Hon. Emilio T. Gregorio, be it;




RESOLVED, FINALLY, to send copies of this resolution to the concerned offices of the government for their information and appropriate action;


