RESOLUTION REQUESTING THE HONORABLE ERNESTO M. MACEDA, SENATE OF THE REPUBLIC OF THE PHILIPPINES, TO EXTEND ASSISTANCE TO THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO IN THE CONSTRUCTION OF SPRING DEVELOPMENT PROJECT IN BARANGAY SAN ROQUE

"WHEREAS, an effective water system is absolutely necessary in order to provide the inhabitants with the precious liquid, water, which is extremely essential for the maintenance and preservation of life;

"WHEREAS, there is an abundance of water sources in this Municipality, particularly in Barangay San Roque, waiting only to be tapped by the proper authorities;

"WHEREAS, an effective waterworks system is needed to bring the water to every household before its use can be fully utilized;

"WHEREAS, considerable amount is needed to finance the construction of waterworks system that will be beneficial to all inhabitants (more than 5,000 of them) of Barangay San Roque;

"WHEREAS, the needed amount is beyond this municipality's financial capability being a fifth class and PRO-POOR Municipality under Presidential Proclamation No. 390;

"WHEREAS, the poor citizen of this barangay are clinging to the hope that good senator will not ignore this plea for support;

"WHEREAS, we know that for Senator MACEDA "BARANGAY AY UNA";

WHEREFORE, upon motion duly seconded, be it:

RESOLVED TO REQUEST, as it hereby requests Hon. Senator Ernesto M. Maceda, Senate of the Philippines to please extend assistance to the Municipality of Bulalacao, Oriental Mindoro in the construction of Spring Development Project in Barangay San Roque;
