EARNESTLY REQUESTING THE HONORABLE MANUEL G. ANDAYA, CONGRESSMAN, 2ND DISTRICT, ORIENTAL MINDORO TO ALLOCATE FUNDS FOR THE CONSTRUCTION OF TWO HUNDRED (200) METERS CONCRETE PERIMETER FENCE AT THE AGRICULTURAL CENTER AND BREEDING STATION (AC/BS) IN BARANGAY NASUCOB, MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

"WHEREAS, in an effort to implement various Agro-Forestry Programs geared towards a sustainable and balanced ecological system, the Municipal Government of Bulalacao has caused the construction of an Agricultural Center and Breeding Station at Barangay Nasucob, this Municipality;

"WHEREAS, the AC/BS Training Center is an added dimension towards an ideal agricultural system which could produce food on a long term sustainable basis, maintain and improve human health, actively preserve and protect the environment, be self-contained and regenerative and conduct research on advanced technological approach;

"WHEREAS, it is happy to note that the municipal government even with limited funds was able to implement almost fifty percent of the project under the supervision of the Municipal Agricultural Office;

"WHEREAS, there is a need to construct a concrete perimeter fence around the AC/BS compound in order to protect the properties inside such as plants, vegetables, flowers and animals which are being raised against persons with malicious intents and astray animals;


