"WHEREAS, the Philippine Crop Insurance Corporation (PCIC) is a government owned and controlled corporation (GOCC) which is the implementing agency of the government's agricultural insurance program, its principal mandate is to provide insurance protection to farmers against losses arising from natural calamities, plant diseases and pest infestations;

"WHEREAS, Bulalacao, a 3rd class municipality is a vast agricultural land, has 15 barangays and with a total agricultural land area of 10,325.80 hectares where 6,016 individuals are employed in the agricultural sector, and has a municipal government that promotes proper utilization of forest land, river, marine and coastal resources, and strengthen agricultural and fishery production and uplift the life of small farmer and fishing communities;

"WHEREAS, from October 23 to 25, the Municipality of Bulalacao was hit by Typhoon Kristine which brought strong winds and heavy rains to the entire municipality for three consecutive days wherein its agriculture and fishery industry were severely damaged that obtained production losses and distress to the farmers of fisherfolks of the municipality;






