REQUESTING DIRECTOR FACUNDO ROCO, PILIPINAS SHELL FOUNDATION, INC. TO FURNISH THE SANGGUNIANG BAYAN OF BULALACAO, ORIENTAL MINDORO WITH A COPY OF THE DISBURSEMENT OF FUNDS INTENDED FOR THE LIVELIHOOD PROJECTS OF BARANGAY BALATASAN, MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

"WHEREAS, the Shell Philippines Exploration allocated the amount of One Million US Dollars (US \$1M) to finance the sustainable development projects for Oriental Mindoro which was affected by the laying of offshore pipelines by the Malampaya Gas Project;

"WHEREAS, the Municipality of Bulalacao in particular learned that a certain amount was allocated for its eight (8) coastal barangays affected by the Malampaya Gas pipelines but sad to say, it did not receive any financial assistance up to this time;


