EARNESTLY REQUESTING THE HONORABLE BARTOLOME L. MARASIGAN, PROVINCIAL GOVERNOR TO ALLOCATE THE AMOUNT OF SEVENTY FIVE THOUSAND PESOS (₱75,000.00) TO BE USED FOR THE CONSTRUCTION OF WATER TANK AT MANGYAN COMMUNITY, SITIO BAGONG BUHAY, CAMBUNANG, BULALACAO, ORIENTAL MINDORO

"WHEREAS, Sitio Bagong Buhay at Barangay Cambunang, Bulalacao, this Province which is primarily composed of the Hanunuo Mangyans suffer difficulties in getting potable water for their daily consumption;

"WHEREAS, it is learned that there is a very reliable water source on the area, however, it will be advantageous if a water tank be constructed to ensure the continuous availability of drinking water;

"WHEREAS, the Municipality of Bulalacao being the Fifth Class Municipality is hounded with financial constraints that this request would only be realized through the assistance of the provincial government; Now, therefore, be it
