EARNESTLY REQUESTING THE HONORABLE ROSARIO N. LOPEZ, CHAIRPERSON, PHILIPPINE CHARITY SWEEPSTAKES OFFICE TO GRANT THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO THE AMOUNT OF ONE MILLION PESOS (1M) TO BE USED FOR THE PURCHASE OF MEDICINES FOR THE INDIGENT RESIDENTS OF THIS MUNICIPALITY;

"WHEREAS, the Municipality of Bulalacao, Province of Oriental Mindoro is a Pro-Poor Municipality pursuant to Executive Order No. 370;

"WHEREAS, the Municipality of Bulalacao which is the southernmost tip of the Province of Oriental Mindoro is composed of a population of twenty percent Hanunuo-Mangyans who does not have access to proper medical treatment and affordable medicines;

"WHEREAS, sufficient medicines added to the availability of medical equipments are necessary in an effort to maintain good health, prevention and control of diseases and in saving lives during the occurrence of emergencies;

"WHEREAS, considering that the progress and stability of one's country is best described by the good sound of health of its people, effective and efficient basic health services is given top priority by this Municipality, however, it appeared to be futile if it is not accompanied by the availability of medicines and medical equipments;

"WHEREAS, faced with financial constraints, the above noble objective would only be realized through the assistance of the Philippine Charity Sweepstakes Office, Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED, To: Earnestly request the Honorable Rosario N. Lopez, Chairperson, Philippine Charity Sweepstakes Office to grant the Municipality of Bulalacao, Province of Oriental Mindoro the amount of One Million Pesos (P1M) to be used for the purchase of medicines for the indigent residents of this Municipality;






