"WHEREAS, electrical energy plays a vital role in everyday life in which the standard of living and well-being of every human being depends on it and that a Filipino home has come to enjoy the comfort and convenience that electrical appliances and fixtures provide;

"WHEREAS, the Municipality of Bulalacao, Oriental Mindoro is experiencing frequent brown-outs brought about by various electrical disturbances such as short circuit, overloading and insufficiency of power supply which brought dismay and dissatisfaction to its people;


"WHEREAS, during the abovementioned electrical disturbances, the consumers find it difficult to report it to the nearest ORMECO Office in Roxas and sometimes they take an initiative to trouble shoot which is more dangerous and prohibited;


