EARNESTLY REQUESTING THE HONORABLE NOLI DE CASTRO, SENATOR, REPUBLIC OF THE PHILIPPINES TO ALLOCATE THE NECESSARY FUNDS FOR THE CONSTRUCTION OF A DORMITORY FOR THE STUDENTS OF THE BULALACAO NATIONAL HIGH SCHOOL, BULALACAO, ORIENTAL MINDORO

"WHEREAS, the Municipality of Bulalacao, Province of Oriental Mindoro is composed of fifteen (15) barangays separated by sea and high mountain ranges making it difficult to reach due to the absence of a good communication and transportation systems;

"WHEREAS, it is observed that students of the Bulalacao National High School coming from far-flung barangays find it difficult to look for a temporary house where they could stay during school days considering that they could not go home everyday;

"WHEREAS, various incidence of criminalities such as rape, murder and robbery are common on television and radio newscasts which are a menace among students, these are crimes that make the parents afraid of sending their children to a far away school;


"WHEREAS, it should be to the best interests and safety of the parents and students alike if a dormitory inside the school campus be provided for them;
