A RESOLUTION REQUESTING THE PHILIPPINE CHARITY SWEEPSTAKES OFFICE THRU ITS CHAIRPERSON, THE HONORABLE MA. LIVIA S. DE LEON, FOR MEDICAL ASSISTANCE IN THE AMOUNT OF THREE MILLION PESOS (P3,000,000.00) FOR THE EFFECTIVE AND EFFICIENT DELIVERY OF BASIC HEALTH SERVICES AMONG THE CONSTITUENTS OF THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO.

‘WHEREAS, the delivery of basic health services has been devolved the Local Government Unit by virtue of Section 17 of Republic Act 1760 otherwise known as the Local Government Code of 1991;
