"WHEREAS, Maujao Elementary School at the Municipality of Bulalacao has only one (1) teacher who caters to the educational needs of pupils at that barangay whose grades range from Grades I to IV;

"WHEREAS, the situation mentioned above defeats the prime objective of having a school which could not meet the quality and enough basic education due to the pupils;




"WHEREAS, it is believed that through the assistance of the Division Superintendent, the abovementioned request be soon realized; Now, therefore, be it
