EARNESTLY REQUESTING THE HONORABLE RENATO "COMPAÑERO" CAYETANO, SENATOR, REPUBLIC OF THE PHILIPPINES TO ALLOCATE THE NECESSARY FUNDS FOR THE CONSTRUCTION OF TWO-CLASSROOM BUILDING FOR MAUJAO NATIONAL HIGH SCHOOL AND ANOTHER TWO-CLASSROOM BUILDING FOR SAN ROQUE NATIONAL HIGH SCHOOL BOTH AT THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

"WHEREAS, the Municipality of Bulalacao, Province of Oriental Mindoro has previously only one secondary school to cater students coming from different barangays which are separated by high mountain ranges and wide sea waters;

"WHEREAS, its geographical feature poses difficulties for the students to go to school at Poblacion that through the combined efforts of the Local Government Unit of Bulalacao and some concerned agencies, the Maujao National High School was established at the south and San Roque National High School was established at the north;

"WHEREAS, the maintenance and other operating expenditures including the salaries of teachers of the newly opened secondary school mentioned above is presently financed by the Local Government Unit of Bulalacao that other facilities and amenities needed most particularly additional classroom building for the increasing enrollees could not be readily provided due to limited funds;

"WHEREAS, it is believed that education is the most basic tool for our search for progress and development so that every effort should be exerted to achieve it to the fullest; Now, therefore, be it


RESOLVED AS IT IS HEREBY RESOLVED; To: Earnestly request the Honorable Renato "Compañero" Cayetano, Senator, Republic of the Philippines to allocate the necessary funds for the construction of two-classroom building for Maujao National High School and another two-classroom building for San Roque National High School both at the Municipality of Bulalacao, Province of Oriental Mindoro;


