**"WHEREAS,** Tuberculosis or "TB" is still a major health problem and considered to be 5<sup>th</sup> leading cause of deaths in the past few years;

**"WHEREAS,** with the implementation of the Directly Observed Treatment Short Course Strategy (DOTS) or "Tutok Gamutan" which lead to achieve a remarkable reduction in TB cases through early detection and cure of infection or smear positive cases, the spread of TB is believed to be controlled if not totally eradicated;


