
"WHEREAS, the construction of the health center at the abovementioned place brought happiness to the residents who have been longing for its completion which was neglected for sometime due to financial constraints;


"WHEREAS, it is seen that with the completion of the health center, the residents of Barangay Nasucob would be best served with their medical needs; Now, therefore, be it


