RESOLUTION NO. 02-01-001

RESOLUTION INDORSING THE NATIONAL GOVERNMENTS PROGRAM ALLOCATING FUNDS FOR THE PURCHASE OF VARIOUS AGRICULTURAL/FARMING IMPLEMENTS AND EQUIPMENTS AMOUNTING TO THIRTY MILLION PESOS (P30M) TAKEN FROM THE LOCAL GOVERNMENT SERVICE EQUALIZATION FUND (LGSEI) AS A FINANCIAL SUPPORT FOR THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

WHEREAS, RA 7160 otherwise known as the Local Government Code of 1991 delegated specific functions and responsibilities to Local Government Unit (LGUs) particularly on the effective and efficient delivery of basic services and facilities at the local level;

WHEREAS, there is an urgent need to provide fund assistance to the LGUs in order to alleviate their financial burdens in carrying but the devolved functions and responsibilities, as specified by the Code;

WHEREAS, Executive Order No. 48, Series of 1998, established a program for Devolution Adjustment and Equalization Fund, renamed as Local Government Service Equalization Fund (LGSEF) which is primarily aimed of enhancing the capacities of LGUs to fully and effectively exercise their devolved functions, services and facilities;

WHEREAS, the Local Government Unit of Bulalacao, Oriental Mindoro lacks the financial capability to bring flesh to the inherent responsibilities incumbent to all Government Unit as well as those powers transferred into them under the process of devolution as already mandated by RA 7160;


WHEREAS, as the representative of its constituents is pinning its hope for any available financial assistance that will come from LGSEF program, Now, therefore, be it
