EARNESTLY REQUESTING HONORABLE JUAN FLAVIER, SENATE COMMITTEE ON HEALTH TO GRANT THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO WITH ONE (1) UNIT OF GARBAGE TRUCK WITH COMPACTOR

"WHEREAS, it is a constitutional mandate that the State shall protect and advance the right of the people to a balance and healthful ecology in accord with the rhythm and harmony of nature;

"WHEREAS, the spread of deadly and contagious diseases due to improper waste disposal and ill-sanitary practice initiated the Local Government Unit of Bulalacao, Oriental Mindoro to prioritize the acquisition of dumping site where waste may be properly disposed and managed;


"WHEREAS, the purchase of a dumping site may appear futile if it should not be accompanied by the provision of a garbage truck with compactor task to regularly gather wastes for proper disposal;

"WHEREAS, being the Pro-Poor Municipality as declared under Proclamation No. 390, the provision of a garbage truck is believed to be realized only through the assistance of the Senate Chairman on Health, the Honorable Juan Flavir; Now, therefore, be it


