EARNESTLY REQUESTING THE HONORABLE PROCESO J. ALCALA, SECRETARY, DEPARTMENT OF AGRICULTURE TO ALLOCATE THE AMOUNT OF THIRTY MILLION PESOS (PHP30M) TO BE USED FOR THE CONSTRUCTION AND REHABILITATION OF FARM TO MARKET ROAD FROM BARANGAY SAN FRANCISCO NATIONAL HIGHWAY TO BARANGAY SAN ISIDRO DOWN TO SITIO CAMBAYANG, BARANGAY CABUGAO, ALL OF THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

"WHEREAS, the progress in the upland barangays such as Barangays San Francisco and San Isidro in the Municipality of Bulalacao, Province of Oriental Mindoro is primarily achieved by providing the necessary infrastructure particularly that of farm to market roads for they shall increase agricultural productivity by providing easy access to sources of productive inputs and high yielding seed varieties and likewise provide easy shipment of goods and movement of people;

"WHEREAS, the concreting of the abovementioned farm to market roads shall help increase greater and faster movement in the area socially and economically for the benefit of its people and the community;

"WHEREAS, it is with high hope that the Department of Agriculture as usual is always ready to help this Pro-Poor Municipality as declared pursuant to Executive Order No. 370; Now, therefore, be it;


**RESOLVED AS IT IS HEREBY RESOLVED, To:** Earnestly request the Honorable Proceso J. Alcala, Secretary, Department of Agriculture to allocate the amount of Thirty Million Pesos (Php30M) to be used for the construction and rehabilitation of farm to market road from Barangay San Francisco National Highway to Barangay San Isidro down to Sitio Cambayang, Barangay Cabugao, all of the Municipality of Bulalacao, Province of Oriental Mindoro;




