RESOLUTION ENDORSING AND SUPPORTING THE CONSTRUCTION OF BANTI - GATOL FARM TO MARKET ROAD SITUATED AT BARANGAY SAN ROQUE, MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO IN THE AMOUNT OF ONE MILLION PESOS (PHP 1 M) TO THE DEPARTMENT OF AGRARIAN REFORM

"WHEREAS, the Department of Agrarian Reform, cognizant of the plight of the marginal farmers of Bulalacao, particularly those living in the hinterlands granted the Municipality of Bulalacao, Oriental Mindoro with a financial assistance in the amount of One Million Pesos (Php 1 M) to be used for the construction of Farm to Market Roads (FMR) particularly from Sitio Banti to Sitio Gatol FMR situated at Barangay San Roque, this Municipality;

"WHEREAS, the construction of Sitio Banti to Sitio Gatol Farm to Market Road would facilitate the movement of people particularly the hanunuo mangyans and shipment of their goods during *tianggihan*;

"WHEREAS, it shall be a great consolation for our brothers and sisters in this area, if they would be provided with a farm to market road which shall trigger economic activities geared towards the upliftment of their social and economic status; Now, therefore, be it
