RESOLUTION NO. 11-02-047

RESOLUTION EXPRESSING SUPPORT FOR THE SOCIAL PROTECTION SUPPORT INITIATIVE PROJECT (SPSI) AND AUTHORIZING THE MUNICIPAL MAYOR TO SIGN THE MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD), DEPARTMENT OF HEALTH (DOH) AND PHILIPPINE HEALTH INSURANCE CORPORATION (PHIC) FOR THE IMPLEMENTATION OF THE SPSI THAT WILL ENHANCE SOCIAL SERVICES DELIVERY TO SELECTED POOR HOUSEHOLDS IN THE MUNICIPALITY

“WHEREAS, the Honorable Ernilo C. Villas, Municipal Mayor in his Endorsement Letter dated February 25, 2011 sought authority from the Sangguniang Bayan to enter into a Memorandum of Agreement with the Department of Social Welfare and Development (DSWD), the Department of Health (DOH) and the Philippine Health Insurance Corporation (PHIC) for the purpose of participating in the Social Protection Support Initiative (SPSI);

“WHEREAS, the DSWD, the DOH and the PHIC are recipients of a grant from the Commission on Information and Communications Technology (CICT) called the eGovernment Fund, supports projects that make use of information and communications technologies (ICTs) in government to facilitate governance, with the aims of strengthening accountability, enhancing supervision and control and, in appropriate cases, facilitating collective decision-making; improving internal administrative processes; enhancing the delivery of service; and empowering citizens to make informed decisions;

"WHEREAS, the individual projects of the DSWD, DOH and PHIC approved for funding by the CICT would bring about convergence in the delivery of social services to poor household beneficiaries, which the latter has collectively called, the Social Protection and Support Initiative (SPSI);

"WHEREAS, the DSWD desires to implement its project called, "Sustaining Interventions in Poverty Alleviation and Governance (SIPAG)," which aims to contribute to the improvement of the well being of poor households and beneficiaries of the Pantawid Pamilya Pilipino Program (Pantawid Pamilya);

"WHEREAS, the DOH desires to implement its project called, "Watching Over Mothers and Babies (WOMB)," which aims to track Maternal and Neonatal Health;

"WHEREAS, the PHIC desires to implement its project called, "Strengthening and Guaranteeing Insurance for the Poor (SAGIP)," which aims to enable indigent members to pay and sustain their health insurance coverage;

"WHEREAS, the Sangguniang Bayan of the Municipality of Bulalacao considers the SPSI a worthwhile project which will provide significant benefits to the poor households of the municipality;


