EARNESTLY REQUESTING THE HONORABLE MIGUEL ZUBIRI, SENATOR, REPUBLIC OF THE PHILIPPINES TO ALLOCATE THE AMOUNT OF SIX HUNDRED THOUSAND PESOS (PHP600,000.00) TO BE USED FOR THE CONSTRUCTION OF PERIMETER FENCE IN THE BULALACAO NATIONAL HIGH SCHOOL MAIN CAMPUS IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

"WHEREAS, it is an earnest desire of the parents, teachers and students of the Bulalacao National High School, Bulalacao, Oriental Mindoro that a concrete perimeter fence be constructed to protect the interest and welfare of both the students and teachers by providing them an environment conducive to learning;


"WHEREAS, faced with financial constraints, this noble objective is believed to be realized through the benevolence of Senator Zubiri, Now, therefore, be it;




