**"WHEREAS,** one of the most requested projects is the provision of streetlights where people feel free and safety to roam around the municipality at nighttime;


"WHEREAS, faced with financial constraint and limited funds, this project is believed to be realized only through the assistance of the good Congressman; Now, therefore, be it






