REQUESTING HIS EXCELLENCY BENIGNO C. AQUINO, III, PRESIDENT, REPUBLIC OF THE PHILIPPINES, TO KINDLY INDORSE TO THE DEPARTMENT OF TOURISM TO GRANT THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO WITH FINANCIAL ASSISTANCE AMOUNTING TO TWENTY FIVE MILLION PESOS (PHP25M) FOR THE CONSTRUCTION OF CONVENTION CENTER CUM HOTEL AND SEA WATER PARK

"WHEREAS, Bulalacao, Oriental Mindoro is one of those municipalities declared as Tourist Reserved Area by virtue of Proclamation No. 1801 along with Boracay and Puerto Galera;

"WHEREAS, albeit the beauty and scenic spots that nature has endowed our town with, still it could hardly jumpstart its tourism development and promotion due to lack of certain facilities and enough financial capital;

"WHEREAS, noticeably investments coming from those established tourist destinations such as owners of resorts, beaches and other tourism oriented businesses have already shown interest by putting initial investments herein;

"WHEREAS, still the Municipal Government is eager to spearhead the tourism development of this town having a newly constructed national highway connecting the 2 provinces of the Island of Mindoro and the on-going construction of RoRo Port it finds the establishment of a Convention Center cum Hotel and Sea Water Park shall be a good start by providing visitors with decent accommodation facilities both for business and recreation purposes;


"WHEREAS, development of local tourism helps not only in the provision of employment but also spur other economic activities that will benefit the majority of our inhabitants; Now, therefore, be it
