CRUZ, REGIONAL DIRECTOR, DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT TO FACILITATE THE IMMEDIATE RELEASE OF FUNDS FROM UNICEF TO BE USED FOR THE CONSTRUCTION OF A DAY CARE CENTER IN THAT BARANGAY

RESOLVED AS IT IS HEREBY RESOLVED, To: Endorse Kapasyahan Big 36 of Barangay Cambunang, Municipality of Bulalacao, Province of Oriental Mindoro requesting Director Violeta A Cruz, Regional Director, Department of Social Welfare and Development to facilitate the immediate release of funds from UNICEF to be used for the construction of a Day Care Center in that barangay;


