RESOLUTION NO. 10-09-094

EARNESTLY REQUESTING THE HONORABLE FERDINAND "BONGBONG" R. MARCOS, SENATOR, REPUBLIC OF THE PHILIPPINES TO ALLOCATE THE AMOUNT OF FIFTEEN MILLION PESOS (PHP15M) TO BE USED FOR THE CONSTRUCTION/REHABILITATION OF FARM TO MARKET ROADS CONNECTING SAN ISIDRO-CABUGAO-BAGONG SIKAT-CAMBAYANG IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

"WHEREAS, Section 1, Article XII of the Constitution provides that the goals of the national economy are more equitable distribution of opportunities, income and wealth, a sustainable increase in the amount of goods and services produced by the Nation for the benefit of the people and an expanding productivity as the key to raising the quality of life for all, especially the underprivileged;

"WHEREAS, Barangays San Isidro, Cabugao and Bagong Sikat, Bulalacao, Oriental Mindoro are vast producers of corn, garlic, onions and hogs such as cows, goats and carabaos wherein a good transportation system is badly needed to provide the farmers thereat access to market;

"WHEREAS, the construction/rehabilitation of farm to market roads mentioned above would help push the implementation of programs and projects geared towards the social and economic development of the inhabitants living in the countrysides; Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED, To: Earnestly request the Honorable Ferdinand "Bongbong" E. Marcos, Senator, Republic of the Philippines to allocate the amount of Fifteen Million Pesos (Php15M) to be used for the construction/rehabilitation of farm to market roads connecting San Isidro-Cabugao-Bagong Sikat-Cambayang in the Municipality of Bulalacao, Province of Oriental Mindoro;
