EARNESTLY REQUESTING HER EXCELLENCY GLORIA MACAPAGAL ARROYO, PRESIDENT, REPUBLIC OF THE PHILIPPINES TO DEFER THE APPROVAL OF THE APPLICATION SUBMITTED BY THE NATIONAL COMMISSION ON INDIGENOUS PEOPLE (NCIP) REGARDING THE DELINEATION OF CERTAIN TERRITORIES IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO AS ANCESTRAL DOMAIN

"WHEREAS, the NCIP applies for the delineation of certain lands in the Municipality of Bulalacao, Province of Oriental Mindoro as Ancestral Domain;

"WHEREAS, approval of said delineation shall violate existing the property rights of people living in the claimed land prior to the passage of IPPRA law,


"WHEREAS, likewise, certain land applied for are covered by certain decrees such as that of P.D. 1801 declaring certain areas of Bulalacao, Oriental Mindoro as Tourist Spot Reserves; and the Special Permit issued by the DENR to develop the coal mining industry at Barangay Cambunang, this Municipality;

"WHEREAS, while it is recognized the importance of promoting the rights of the Hanunuo-Mangyans who comprised the 30% of total population it is also but proper to have the necessary consultation within the different concerned sectors to put the issue into its proper perspective which is the promotion of the general welfare of the inhabitants; Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED, To: Earnestly request Her Excellency Gloria Macapagal Arroyo, President, Republic of the Philippines to defer the approval of the application submitted by the National Commission on Indigenous People (NCIP) regarding the delineation of certain territories in the Municipality of Bulalacao, Province of Oriental Mindoro as Ancestral Domain,






