ALCALA, SECRETARY, DEPARTMENT OF AGRICULTURE (DA) TO GRANT THE AMOUNT OF TEN MILLION PESOS (PHP10M) TO BE USED FOR THE CONSTRUCTION/REHABILITATION OF SITIO BANGKAL TO SITIO LIBTONG TO SITIO DANGKALAN, BARANGAY SAN JUAN SIX KILOMETER (6km) FARM TO MARKET ROADS




