EARNESTLY REQUESTING THE HONORABLE PROCESO J. ALCALA, SECRETARY, DEPARTMENT OF AGRICULTURE (DA) TO GRANT THE AMOUNT OF TEN MILLION PESOS (PHP10M) TO BE USED FOR THE CONSTRUCTION/REHABILITATION OF BARANGAY BENLI PROPER TO SITIO CAGURAY FIVE KILOMETER (5km) FARM TO MARKET ROADS
